Q WILL PROPOSITION 44 IMPROVE PATIENT CARE?

- A**
- No. Prop 44 is a major threat to nearly 7 million patients who rely on community health clinics for their care.
 - Healthcare economists warn Prop 44 will **cut \$1.7 billion from community health clinics in the first year alone** and billions thereafter. As a result, 88% of clinics across the state would operate at a loss.
 - Prop 44 will **shut down hundreds of community health clinics** throughout the state and force major cuts to patient services, jeopardizing access to care for millions of patients.

Q WHAT PATIENT SERVICES ARE AT RISK UNDER PROP 44?

- Prop 44 will **shut down hundreds of clinics and force clinics to eliminate vital patient services.**
 - What's more, Prop 44 has major legal flaws that **financially penalize clinics if they spend resources on important staff and patient services.**

WHY WAS PROP 44 FILED?

- Proposition 44 is backed by a special interest labor union that is **using the ballot initiative process to advance its political agenda.**
- This **same union has spent more than \$200 million pushing dozens of harmful ballot measures** against hospitals, clinics and physician groups, including the three unsuccessful dialysis propositions that voters overwhelmingly rejected every time.
- Workers have a right to decide whether to join a union. But using the ballot initiative process to advance a political agenda at the expense of patients and community health clinics is wrong. **Patients should never be used as pawns.**



WILL PROP 44 STRENGTHEN OVERSIGHT AND ACCOUNTABILITY OVER COMMUNITY HEALTH CENTERS AND CLINICS?

- No. **Prop 44 is unnecessary.** Community clinics are heavily regulated by the federal and state governments with mandatory spending requirements, public audits and reporting of clinic spending.
- Prop 44 puts the State Attorney General in charge of decisions about the services health clinics can provide. **The last thing we need is politicians to interfere** in decisions that should be between patients and their doctors and nurses.



DO COMMUNITY HEALTH CLINICS SPEND TOO MUCH ON MANAGEMENT OR EXECUTIVES?

- Community clinics are all **not-for-profit organizations, led by a board that includes patients**, requiring funds to be spent on patient care and community benefits.
- Community clinics **provide compensation for management and executives the same way they set compensation for providers and all employees**, they pay competitive wages and benefits that allow them to recruit and retain the most qualified caregivers and leaders.
